All persons wishing to join ndsme will join as a *Prospective Member* on their initial application at the fees specified.

Because the ndsme is a limited company it chooses to exercise discretion as to who is admitted to be a full member of the company. Each new applicant joins first as a prospective member and after a minimum of 12 months satisfactory membership then the applicant may, at the discretion of the Directors, be considered for full member status. Please note that if your initial application covers a period of less than twelve months you would need to renew on a prospective member form, not a full member renewal form.

During the prospective membership period, the applicant may take a full part in most society activities and will be under ndsme insurance policies to so do. The society organises occasional meetings and it is expected that prospective members will avail themselves of the facilities on offer. They may also receive by email a prospective members ebulletin from time to time. As a prospective member there is no entitlement to vote at the company AGM or to stand for/be appointed to any formal position. This will be awarded with full membership after a satisfactory prospective membership period.
